Plans were sent to Codeworks for comments. The Board recommended looking at drainage off the building and direct runoff towards the west and future detention site. There have been some issues along the north property line. The plan shows landscape screening on the north side. Dave St. Pierre submitted code review comments. The size and use of the building as submitted does require a sprinkler system. Koch Hazard submitted a revised plan limiting the fire areas to less than 5000 sf. Final Plans will be submitted to Code Works for approval. HDR reviewed the site plan and submitted comments to address.
